- 1. Approve Minutes from September 19, 2016
  - a. Approved, no corrections
- 2. Classified Leadership Institute (CLI) June 15-17, 2016 Erin Moore
  - a. Funds are being allocated by the Classified Professional Development Work Group every other year because it is more feasible and affordable for our employees to attend when it is in Tahoe (as opposed to every other year in Ventura)
  - b. Hasn't been broadcast as an opportunity, want to promote it and encourage Classified Staff to take advantage of it
