This is the first of the three enrollment updates for this term. The dates for the three updates are: the End of the First Day of Classes (January 20, 2016), the Last Day to Add/Drop (February 2, 2016) and the Official Census Day (February 8, 2016). The Board of Trustees receives formal reports from my office on the data from the Official Census Day. Please note there is a two-week delay in certifying the Official Census Day data.

*Special Notice: To make our productivity reports more accurate, effective fall 2010, contract courses (attendance method = OC) are excluded from Enrollment, FTES, WSCH, Load and Sections. Data from all prior terms still include these courses, however, the impact of this change is expected to be small. For this report, Course Enrollments, FTES, and Load are based on DESR-history files.

Note: Change refers to the difference in percentages from a comparable day a year ago. For Spring 2016 the change is computed by the first day of classes starts on 1/22/15.

\*FTES: Full Time Equivalent Student. It is a point in time and will change as the semester progresses.

\*\*Load: Teaching Load is taken as the ratio of WSCH to FTE. It is a point in time and will change as the semester progresses.
