#### VI. Standing Items

#### a. Planning and Budgeting Council

The last PBC meeting was September 20.

The 2023-2024 budget which the Board of Trustees adopted Sept. 13 was presented to PBC. Highlights:

- Property taxes are projected to increase 6.87% over 2022-23.
- Funding is set aside to support community priorities
- There is a 15% reserve set aside for unforeseen events.

• Colleges set aside funds for capital projects not funded by bonds. Since the SMCCCD is a basic aid district, it does not get a lot of money for the unrestricted general fund but receives some funds for categorical programs. The state revenue is projecting some declines as compared to the prior year.

- 2. If your program is up for comprehensive program review this year, enter your <u>Comprehensive Program Review</u>. If you're not up for comprehensive program this year and you have resources you want to request this year, enter an <u>Annual Update</u>.
- 3. If you are requesting resources, be sure to complete STEP 2 in Nuventive.

- Submit your complete Comprehensive Program Review or Annual Update before October 13, 2023.
- 5. Deans and VPs <u>complete feedback of all program review materials</u> and send out **before October 27, 2023.**
- Review your supervisor's feedback and incorporate it into your program review before November 3, 2023.

Consider reframing the way you think about requesting resources. This is our opportunity to say to the college this is how we're doing and this is what we need. If you're in a Comprehensive Review, you're doing a deep dive into cycles and data and understanding how that ebbs and flows throughout the year as a program or as an office but if you are not and you need resource, and a resource could be funding in your office budget, I need to hire an employee, I need to expand my program so if it requires money from the college, that's a resource request. This should come through as an Annual Update. If you need to do an Annual Update to request resources, have an ongoing dialogue with your administrator so no one is surprised but also so you're supported.

Each department or program need to have SAOs in Nuventive.

#### VIII. New Business

#### a. SSPC Co-Chair Appointment & Membership Update

i. Co-Chair Nominee: Juan Vera

At our last meeting we received a nomination for Juan Vera to serve as our co-chair for SSPC. At that meeting he was undecided if he would like to co-chair but since then he's decided he's 100% ready to be a nominee for this positon.

ii. Membership Update: Cultural Center, Wellness Center

The Cultural Center is now a formal part of our structure at Cañada College. The question has been raised as to whether we should add the Cultural Center as a voting member of the SSPC?

The Director of the Cultural Center is also the Director of Equity for the campus. It seems this new center and the Director of Equity is an integral part of Student Services and should have a seat at the table.

If the SSPC votes to add the Cultural Center to the membership, the membership doesn't have to be tied to a position. It could be a representative either Maggie de Paz Fernandez (Program Services Coordinator for the Cultural Center) or Michiko Kealoha (Director).

At this time our membership is at 27 with a quorum at 14 so if we add a 28<sup>th</sup> member, the quorum will be 15.

Max Hartman motions to add a Cultural Center representative to the SSPC membership roster Sergio Suarez and Mary Ho both second the motion Approved by all those in attendance

Our PBC representative will let PBC know we've included the Cultural Center representative as a member of SSPC.

Years ago SSPC had individual representatives from each of the Centers; the Disability Resource Center, the Personal Counseling Center and the Health Center. Once these centers came under the umbrella of the Wellness Center, SSPC changed the representation to one representative. When the new building 1 opened and was named the Kinesiology and Wellness Center, we dropped the umbrella name for the three centers so we wouldn't confuse students.

At this time the Health Center is under the Enrollment Services and Support Programs Division while the DRC and PCC are under the Counseling Division. We would like SSPC to consider adding representation so all three centers feel they have adequate representation on this council.

One suggested motion would be to no longer have a Wellness Representative on SSPC but instead have one representative from the DRC/PCC and one representative from the Health Center.

Bettina Lee is the representative for the Wellness Center at this time. What is the position on this subject from the Health Center? We want to make sure the Health Center feels good about what is decided here today, especially if we decide to include them as a voting member. At this time Bettina won't be able to answer this question. Bettina believes Dr. Bennani has had these conversations with the Health Center team.

We'll put this item back on the agenda and wait to hear from Dr. Bennani. At the next meeting we'll entertain any type of motion to reflect the decisions made by the three centers.

#### **IX. Old Business**

a. Revisiting – Student Drop for Non-Payment (continued)

At the last meeting we shared some preliminary data that we received from the PRIE office in response to some questions that we all developed and the Make Registration Easier workgroup developed around the drop for non-payment. Some of the questions were what are the dollar amounts, how many students were dropped, if those students are dropped, do they come back and re-enroll? The take-away for many of us didn't see a clear pattern in the data. We need to move forward with a clear proposal for ESC that can support our students.

After our last SSPC meeting we (Max, Wissem, Danielle, Lorraine, Maria H.) had a conversation and went more in-depth over the data, talked through it and asked what additional questions we have? One of the conflicting variables that emerged from the data is that we've had a number of applications or persons who go through the matriculation process and even register who are not, in fact, actual students. So one of the potential checks for our limited resources on campus has been our drop for non-payment process. What are the impacts on our campus from this? What policies can we propose to ensure we are supporting our students and not dropping anyone who is actually a student and protecting our college?

One of the ideas we had was excluding continuing students from drop for non-payment process because we already know they are students. We still have more questions that we're waiting for PRIE to respond to.

Our next Making Registration Easier meeting will be Thursday, October 12 at 2:00-3:30.

From just the timeline perspective the proposals we make now will impact Summer 2024 and Fall 2024.
