- i. No updates since January. The funding that Cañada has been awarded hasn't yet been released to the district. (All other colleges are also awaiting their funds.) More information in our March meeting.
- III. New Agenda Item: OER/ZTC Project Coordinator Proposal (10 minutes; Information/Discussion)
 - a. Using the funding that the college will receive from the CCCCO 2025 ZTC Allocation, the proposal would be to create a 2-year, grant-funded position to do all of the data, analysis and budget work associated with the OER/ZTC program. This would be a 12-month Classified Managerial position. (District HR will inform Dean Rana of the specific position level.)
 - b. Duties include working with Library and Distance Education faculty in managing ZTC projects, collecting and analyzing data, creating and managing ZTC budgets, applying for and attaining grant funding, identifying ZTC/LTC courses and marking them in Banner/WebSchedule.
 - c. Much of this work is outside faculty purview, particularly with respect to budget and working in Banner.
 - d. A new OERI Liaison would be appointed (one of the Librarians, most probably), with the current OER/ZTC Coordinator position being phased out.
 - e. Dean Rana has taken this to the President's Cabinet, who do support it. She will be taking this to Academic Senate on 27 February, and to Planning and Budgeting Council after that.
 - f. If there isn't enough support for the position, alternatives will be identified to ensure that the work is continued.
