#### **CUNY ASAP Visit**

A team of staff and faculty visited NYC to learn more about the highly successful CUNY Accelerated Study in Associate Program (ASAP). The visiting team gathered more information on the replication efforts for our district through the Promise Scholars Program. In addition to our team we were joined by CSM, Skyline and representatives from Cuesta College, Lake Tahoe Community College, and Pasadena City College and Nashville State Community College. The team presented the work we are currently doing with the Promise Scholars Program and were able to spend time visiting various colleges in the CUNY system like Bronx Community College, Borough of Manhattan Community College and Queensborough Community College to get technical assistance for the full replication roll out across the district.

### New States Added to Travel Restrictions List

As a reminder, District travel procedure states that: "No business-related travel will be approved or permitted to states with discriminatory laws against lesbian, gay, bisexual, and transgender people. The California Attorney General, per AB 1887, maintains and publishes a list (<a href="https://oag.ca.gov/ab1887">https://oag.ca.gov/ab1887</a>) of such states; the District will recognize that list for this purpose."

The California Attorney General has updated this list, which now includes the following states:

- 1. Alabama
- 2. Kansas
- 3. Kentucky
- 4. Mississippi
- 5. North Carolina
- 6. Oklahoma
- 7. South Carolina
- 8. South Dakota
- 9. Tennessee
- 10. Texas

District procedures also note that, "Any exception to this prohibition for the purpose of health, safety or student need, in addition to those exceptions provided in AB 1887, must be approved by the Chancellor in advance of any such travel. Requests for an exception should be directed to the Chief of Staff in the Chancellor's office (baileym@smccd.edu)."
