Planning & Budgeting Council Updates

At its meeting this week, the Planning & Budgeting Council (PBC):

- Heard an <u>update</u> from VPAS Graciano Mendoza on the state and college budget and approved and funded personnel for 2021-22
- Approved and recommended to the President that the College <u>adopt a revised</u> <u>process</u> for non-personnel resource request prioritization (now done at the Division level).
- Approved and recommended to the President that the College adopt the Distance Education Advisory Committee's (DEAC) <u>updated college plan for</u> <u>distance education</u> at Cañada.
- Approved and recommended to the President that the College adopt <u>the</u> recommendations of the College's Antiracism Task Force.
- Approved and an update to the <u>bylaws</u> for the Academic Committee for Equity and Success (ACES) as well as an update to the bylaws of the Student Services Planning Council.
- Heard a progress report on the College's Annual Plan for 2020-21.
- Heard presentations and brief Q&A's with two consultant teams being considered
 to assist the College in its Educational Master Planning and Antiracism efforts in
 2021-22. The Scope of Work to which the consultants responded as well as their

FCC Launches Emergency Broadband Benefit

The Federal Communications Commission has launched a temporary program to help families and households struggling to afford Internet service during the COVID-19 pandemic. The Emergency Broadband Benefit provides a discount of up to \$50 per month toward broadband service for eligible households and up to \$75 per month for households on qualifying Tribal lands. Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers. Eligible households can enroll through a participating broadband provider or directly with the Universal Service Administrative Company (USAC) using an online or mail in application. Getting Ready for Program Review!

On behalf of PBC, SSPC, IPC and Academic Senate, the <u>Program Review Work Group</u> has been meeting regularly throughout the Spring semester in preparation for the 2021-2022 Program Review Cycle, which begins in the Fall. The purpose of our Work Group is to help coordinate and support an effective program review process each year across instructional, administrative, and student services programs. We wanted to share with you a few updates before we all leave for the summer, so that you can be prepared for submitting program review in the Fall.

Timeline Updates

A few small changes have been made to the <u>Program Review timeline</u>, making *program review data and resources available in mid-June* and clarifying the role of the Dean's/VP's feedback in the process.

2021-2022 Due Dates

- Submit your complete Comprehensive Program Review or Annual Update, and resources requests if needed, before October 15, 2021.
- Deans and VPs complete feedback of all program review materials and send out before October 29, 2021.
- Review your Dean's/VP's feedback and incorporate it into your program review before November 5, 2021.

New Cycle (Are you up for program review this Fall?) & Guides

There have been changes to our program review cycle, so be sure to double check the <u>Administrative</u>, <u>Instructional</u>, or <u>Student Services</u> Program Review Schedules to see if your program is up for comprehensive program review in the 2021-2022 cycle. Note that if you're not up for comprehensive program review in the 2021-2022 cycle and would like to request resources, you will need to submit an Annual Update.
