#### **Community Gathering in Support of SB 893**

Thank you to the Cañada students, faculty and staff who joined our District Office, Skyline and CSM colleagues yesterday in support of Free Community College in San Mateo County, through Senate Bill 893. The event drew more than 150 people, including several elected officials and community partners who are supporting the bill. SB 893, authored by Sen. Josh Becker and co-authored by Assemblymembers Kevin Mullin and Marc Berman, has been passed by both chambers of the California Legislature and awaits the Governor's signature. SB 893 will allow the San Mateo County Community College District to use its existing local funds to pay for enrollment fees, books, educational materials and supplies, and basic needs costs such as transportation, food and housing for students most in need. Current law restricts the use of general fund dollars for such items, and SB 893 will make college more accessible and affordable in San Mateo County. ### **Online Equity Academy**

Registration is open (and free for SMCCCD employees) for the <u>Equity Academy Level</u> <u>1: Fundamentals of Equity</u> course presented by Skyline College's Equity Institute, which launches on Monday, October 17. This is a fully-online, four-week professional development opportunity for individuals and teams to learn baseline concepts, interrogate data and map implementation strategy to advance the equity-centered work at their respective institutions. The course is informed by anti-racist and anti-sexist pedagogies and practices rooted in social justice frameworks providing participants the opportunity to engage in facilitated activities and discussions.

What you can expect: The Equity Academy course is designed to be completed asynchronously, providing flexibility for working professionals to complete the training at their own convenience and pace. They will also get the chance to come together virtually twice a week for a one-hour facilitated dialogue that will build social support and ensure meaningful connection and interaction.

### Raffle/Fundraising Update from SMCCC Foundation

The SMCCC Foundation reminds the campus community that any raffles at the three colleges (or the District), must go through the SMCCC Foundation. In order to comply with California law and the state constitution, the Foundation needs to know the costs associated with putting on the raffle, how much is collected in proceeds, and an assurance that at least 90 percent of the proceeds are used for charitable purposes (for example, if \$100 is collected in ticket sales, \$90 has to go to the charitable purpose, and \$10 can go to raffle expenses). Raffles may only be for charitable purposes.

The SMCCC Foundation has created a <u>fundraising activities notification worksheet</u>, so campus groups can provide advance notice of any fundraising activity they are conducting, including raffles. SMCCC Foundation has asked for two months' notice for raffles. Once the raffle is over, there is a <u>collaboration raffle form</u> that needs to be filled out within a week of completion of the raffle.

# **COVID Prevention Program Plan Updates**

Earlier this week, the District sent communication about its <u>COVID-19 Prevention</u> <u>Program Plan</u> that has been modified to reflect the most up-to-date COVID-19 procedures and policies.

Key updates include:

- Face Coverings and Personal Protective Equipment (PPE) SOP
- Investigating / Responding to COVID-19 Cases in the Workplace and Reporting, Recordkeeping, and Access SOPs
- COVID-19 Testing for Unvaccinated Medical and Sincerely Held Religious Beliefs Exempt Individuals SOP
