Senate Bill 893, Supporting SMCCCD, Sent to Governor

You may have read in yesterday's San Mateo Daily Journal that SB 893, a bill authored by state Sen. Josh Becker, D-San Mateo, is on its way to be signed into law by Gov. Gavin Newsom. If signed, SMCCCD would be allowed to offer fee waivers to more students in need by using existing local revenue and without incurring further costs to the state. The bill, which allows SMCCCD to expand its Free College initiatives, will also provide aid to underrepresented and marginalized community members using unrestricted local funds. As campus community members have observed, progress is occurring on the modernization project of Building 13. However, there have been severe supply chain delays and labor shortages due to COVID. With this, we felt it was important to share an updated, tentative timeline from our District Facilities team for the Building 13 modernization project:

- Contractor Completion November 2022
- Furniture Installation December 2022/January 2023
- ITS Equipment tentative delivery March/April 2023
- ITS Installation/Testing March May 2023
- Staff Move-in tentatively set for Summer 2023
- Classrooms Available for Classes Summer or Fall 2023

In addition, please save the date for a campus-wide Facilities Forum scheduled for Friday, Dec. 2 from 1-2 p.m. At the Facilities Forum, the Capital Improvement team will provide an update on the various construction projects that are occurring at the College.
