

A Message from President Kim Lopez

Dear Cañada Colleagues,

Commitment to Supporting Our Undocumented Community

Earlier this week, District Communications sent a joint message from the Chancellor and College Presidents reaffirming its commitment to providing a safe and welcoming educational environment for all students, including undocumented individuals. The full message can be read <u>here</u> and includes steps to follow if employees become aware of immigration enforcement activities on campus:

- 1. **NOTIFY the President's Office immediately.** No employee outside of the President's Office is authorized to accept legal documents from immigration enforcement officers.
- 2. DOCUMENT and provide the President's Office with all details of immigration enforcement activities as soon as possible. Include time, location, officer name/credential, and details of officer's request, if known.
- 3. **ESCORT officers to the President's Office**. If you do not feel comfortable escorting officers, contact Public Safety at (650) 738-7000 to assist. You are prohibited from giving consent for an immigration officer to enter any non-public area of campus (e.g. classrooms, office areas, etc.). If an officer arrives in the evening when the President's Office is closed, please contact Public Safety.

- ENTREGUE ESTA TARJETA AL AGENTE. Si usted está dentro de su casa, muestre la tarjeta por la ventana o pásela debajo de la puerta.

l do not wish to speak with you, answer your questions, or sign or hand you any documents based on my 5th Amendment rights under the United States Constitution.

I do not give you permission to enter my home based on my 4th Amendment rights under the United States Constitution unless you have a warrant to enter, signed by a judge or magistrate with my name on it that you slide under the door.

l do not give you permission to search any of my belongings based on my 4th Amendment rights.

I choose to exercise my constitutional rights.
