## GOALS AND OBJECTIVES FOR 2015-16

**GOAL 1: Optimize the use of new and existing technologies throughout the College by providing technology- related professional development resources to faculty and staff.**

**Objective 1.1 The instructional designer, CIETL, and Professional Development committee will promote and increase training opportunities (internal and external) for faculty and staff to learn to use technology more effectively.**

1.) The Professional Development Coordinator and the part-time Instructional Technologist have offered faculty ongoing training in Canvas. Faculty are now able to use the college's learning management system more effectively for both in person and online instruction.

2.) The college has hired a full-time Instructional Technologist to assist faculty, administrators and staff with ongoing technology needs and training. The Instructional Technologist assist faculty with the recent Canvas conversion. The college also now has a faculty member serving as the college's Online Education Coordinator. Both of these individuals will assist with technology needs, distance education needs, and online pedagogy.

3.) The college's technology committee met twice this year and has several more meetings planned for during calendar year 2016. The meetings have address the college's technology replacement plan. Specifically, the meetings have addressed the program review process for requesting new technology needs as well as the college replacement process for broken technology.

4.) The technology committee has revised the technology survey. A small taskforce consisting of the technology committee chairs, the director of professional development and the district webmaster will meet to review the survey questions and input the questions in the survey instrument. The plan is to send the survey to the campus community this fall.

**Objective 1.2 Develop and administer instruments that survey and assess the technology training needs of faculty and staff.**
