- Where are we?
 - Current cycle 2020 2023
 - MOU specific to high-volume or high-demand professional duties, which included SLOs, occurred during two of the three years of the cycle:
 - Fall 2020, Spring 2021, Fall 2021, & Spring 2022
 - Current cycle ends Spring 2023
- Plans moving forward?
 - Complete current assessment plans
 - Make sure to input all assessment results into Nuventive Improve
 - Create new 3-year this semester (new plan will start Fall 2023)

Service Area Outcomes

The Student Services Planning Council will support all student support services in reviewing and updating – as needed – their service area outcomes during the spring of 2023.

 - Retrain on Nuventive platform in light of regular and comprehensive SS assessments

We got very helpful feedback on this year's program review process

- 33 staff and faculty responded to the program review process feedback survey last fall
- The PBC Program Review Work Group has synthesized this feedback and will be making recommendations for process improvements to the Academic and Classified Senates as well as PBC.



Improving our culture of self-assessment and continuous improvement

Instruction

- Instructional Programs use COR updating cycle (5 or 2 years) to review the SLOs for their courses.
- All instructional and learning support programs plan their SLO assessments via three-year assessment plans.

Student Services

• Student Services Programs are updating their Student Learning Outcomes or Service Area Outcomes to support the Transformational Antiracism Leadership Framework SSPC adopted last year.

Administrative Services

Also updating their self-assessment methods and procedures
