a) "Why" We Do What We Do Share (Wissem Bennani)

2 mins

i) An instance that has happened recently that has reminded you why you do what you do to challenge equity and anti-racism in Student Services

Wissem Bennani mentioned the last time he shared was a student success story and the feeling associated with that. Today he wants to share more about the big picture. "During the year 2021, the world has witnessed major events. To name a few, the January 6 attach on the capital that forced congress to evacuate, the Taliban offensive in August that led to a large group of people looking for ways to flee Afghanistan scared for their lives and we also witnessed the disaster caused by international wildfires in Turkey, Greece and California and other natural disasters, such as what happened in Haiti. Every time I see these events I ask myself what can I do to be part of the solution. As a social justice educator, it is a personal goal for me to challenge racist policies and to remove barriers so that underserved students and communities have access to high quality education. As an international education practitioner, I believe that education is the key to world peace and I believe that education for sustainable development will help us mitigate the impact of global warming to avoid the unfortunate events we've witness in 2021. The fact that I am part of a district, a college and a team of student service professionals that embrace the values of equity, social justice, anti-racism, and sustainability is why I do what I do."

5) Standing Items (17 minutes)

a) PBC Max / 4 mins

Our last PBC meeting was on Wednesday, October 20. If you are interested in being the SSPC representative for PBC, contact Max.

There was a reminder about the personnel request process and upcoming forums. The first deadline has passed for submitting the proposals for the annual updates for program review. Deans and Vice Presidents are reviewing those and providing feedback to the programs for the final submission on November 5. Once those positions are submitted we'll continue the regular process with the forums and presentations. There has been some back and forth discussion with PBC and the Program Review Task Force about providing proposers with an optional template that can be used for the presentations. The presentations will be approximately 10 minutes for each presentations. It will ultimately depend on how many presentations we have. The presentations will be happening in November.

b) VPSS Updates

HACU – Hispanic Association of Colleges and Universities which is one of the largest umbrella organizations on the Federal level that support institutions that are HSI (Hispanic Serving Institutions. Cañada College is an HSI. Being a member of HACU keeps us updated on the latest information and gives us more opportunities to support our LatinX students.

There have been a lot of questions about our Spring 2022 return to campus, our process, our schedules, and the vaccination uploads. Later in today's agenda we're going to have a very intentional and deep conversation about the return specifically.

Reminder that we are having our first Student Services Huddle. We're calling it a huddle because it is a moment for us talk about what's happening on campus, what and how's it going in Student Services, and a moment for us to get together

in an informal setting. It's a space where we'll be engaging in conversation with one another, we'll have some snacks and music. We'll also have a microphone in case anyone wants to ask questions.

The District has approved and moved forward our three District priorities. Using one time funds, from their coffers, they will be supporting zero cost textbooks, Dual Enrollment, and Promise Scholars program. This will be a three year one time funding project. There will be more information at upcoming SSPC meetings.

c) Enrollment Services Committee Update


6) Business Items (80 mins)

a) Transformational & Anti-Racist Leadership discussion

We want to be very intentional in seeking to have

transformational anti-racist leadership. To avoid a words only system we want to have action. To do that we need to have everyone's help. We have an opportunity to do both internal work, as well as relationship and systems oriented work.

Town Hall Debrief Manuel / 25 mins



Question: Being a public campus are we going to be able to serve the public and community members who are not students yet or someone who wants to come in and use the computer to apply to the college. Will they need to show proof of vaccination?

Answer: At this point in time none of us will be in the business of verifying vaccination proof right in the moment, at any counter, or in any office space.

The Vice Presidents and Deans are in active conversations about how we will know if the possible students or community members who come on campus are vaccinated or not.

Question: Will we continue zoom meetings or have hybrid meetings?

Answer: At this time we don't think hybridity is going away. This looks like it will be the next wave of higher education in supporting our students and meeting our community where they're at. Right now there is no decree one way or another. There is no stipulation that in the Spring we'll do away with hybrid or do away with virtual.

Question: How are we talking about tension between safety and access?

Answer: This question dovetails into my first response. It's related. We're trying to find a way to track who is coming on our campus and not being vaccinated and how to do affective contract tracing in the event anyone does get sick.

Comment: It might help having a Board Member or two come to one of our Town Halls so they can hear our frustration first hand.

Question: How are we student centered when we seek to remove student rights because they are not yet law? (religious exemption)

Answer: This is an amazing practice in the layers of our participatory governance leadership. The participatory governance leadership is in place so we collect all the different voices and perspectives and then inform an opinion. This doesn't mean there is consensus. There's a reason it's called participatory governance. There is not wide spread consensus on all sides of this conversation. There are senior leaders who believe we should extend the same rights to students and also some of the senior leaders who believe we should not.

b) NDNU Bachelor Degree Completion Pathway in Business Administration

Mary / 15 mins

This completion pathway conversation began over a year ago at the District level. Mary Ho was able to begin working with Melissa McAlexander in June developing the pathway more fully, which includes an affordability plan for Financial Aid students and a full wrap around support plan for students. This program is open to all students in our District. Our hope is to begin the first cohort in Spring 2022.

Melissa McAlexander from Notre Dame de Namur University (NDNU) presented information regarding the Bachelor's Degree Completion Pathway in Business Administration.

B.S. Business Administration

Seamless pathway to a bachelor's degree for students who have earned their Associate in Science for Transfer in Business Administration.

All 60 AS-T Business Administration credits transfer to NDNU and NDNU commits to offer the remaining 60 units of coursework such that students can complete a Bachelor of Science in Business Administration (BSBA) in **2 years**.



Transfer Admissions Process

Admissions Process

- Complete application
- Deposit \$100 (Counts toward tuition)
- FAFSA filing (for Financial Aid) finaid@ndnu.edu for help
- University transcripts showing conferred degree and 2.0 GPA (no later than January 31, 2022)

Once admitted, students will work with Transfer Advisor on course enrollments and preparation.



Tuition for Spring 2022: \$7,896 for 12 units

Summer tuition expected: about \$4,000 for 6 units (pending board approval as part of 2022-2023 tuition rates).

Financial Aid could include (based on FAFSA)

- Federal Grants (e.g., Pell Grant)
- State Grants (e.g., Cal Grant)
- Generous Institutional Aid and Scholarships for those with demonstrated financial need
- 1:1 counseling available, even before admission
