V. Hearing of The Public	<i>Vice-President Valenzuela</i>

	Alex Wildman- has her interview for a senator position	
Student Trustee Rupinder Bajwa has come to the meeting to inform the members about the Measure H Bond . He informs the members and the public that the Measure H Bond consists of 477 million dollars, that if approved would be distributed among 3 colleges (Skyline, CSM, and Cañada). He goes further to explain that if the bond is approved, the money would go towards the construction of some buildings as well as the demolition of others- Building one would be demolished, and a newer building with updated facilities would be built in its place. Rupinder Bajwa makes it clear that he is in no way trying to persuade the AS to accept the bond, only informing them about the changes that would occur if the bond were accepted. He delves further into		

the subject by notifying the AS that even if the bond were accepted, Capital needs would still not be met and there will still be a deficit, however, the bond would be a step in the right direction. **President Javier Santos** shares that Cañada took a formal stance on August 7th, 2014 to accept the bond measure, and tells the room that a club can be made to promote and share what the **Measure H Bond** has to offer. **Vice-President Evelyn Valenzuela** tells **Rupinder** that he is interested, he can attend the Cañada Halloween event on October 30th to inform students more about the measure H bond and everything that it has to offer.

Senator Jithan Tennakoon asks if AS members are allowed to advocate for the bond and is told that it is okay as long as no AS money is used to do so.
