VPSS Bricker safe spaces on campus (Discussion)

Touched on Flyer for Constitution Day and what information do we have around safe spaces, particularly connected to ice and any potential ice activity. While SMCCD maintains resources for undocumented students and has legal protections under FERPA and California's SB 54 (Values Act) that restrict cooperation with immigration enforcement, the reality has shifted significantly. Based on observed ICE behavior, federal agents are ignoring California laws and safe space designations, leading the district to conclude that "there are no safe spaces for immigration enforcement." The new protocol advises faculty to state "I do not consent to your entry" if agents enter classrooms and refer them to administration, but the primary focus has shifted from preventing enforcement to documenting incidents with cameras and evidence collection to optimize legal defense after the fact. The district will provide legal defense for employees and students, but the emphasis is now on realistic preparation rather Shaunda seconds than relying on legal protections that are being ignored in practice. Mainly focused on taking evidence like video if something happens.
