Informally, ITS/Chris can advise individuals of an existing tool or license that meets the need requested but there is not formal process currently</li> <li>3 yrs ago VP Council created request process via ITS and General Services to ensure we're following legal and other req's before moving ahead with a new adoption</li> </ul>

ITS is working on plans to get this done</li> <li>Consider that TCM has a more broad purview than college DEAC, is more logical place to establish an evaluation process to review whether the proposed adoption meets criteria</li> <li>ITS Request process:         <ul> <li>Accessibility reviews, Privacy review</li> <li>After review, ITS makes rec, goes to Dean or lead in area, if a larger request, will go through add'l process</li> <li>Current gap: no general interest form to take the request through a first-level college review, before it goes to ITS review or alternatively, receiving result following ITS review</li> <li>ESC also has a role in process via technology prioritization process</li> </ul> </li> </ul>
